हिंदुजा रुग्णालयातील सल्लागार संसर्गजन्य रोग विशेषज्ञ डॉ. उमंग अग्रवाल यांनी सांगितले की, १५ दिवसांत सुमारे ४० ते ४५ जणांना स्वाईन फ्लूचे निदान झाले. त्यापैकी १० ते १५ टक्के रुग्णांना रुग्णालयात दाखल करणे आवश्यक होते. एचएन रिलायन्स हॉस्पिटलच्या इंटरनल मेडिसिन संचालक डॉ. प्रीती छाब्रिया यांनी सांगितले की, काही दिवसांत एकूण १० जणांना स्वाईन फ्लूचे निदान झाले. मात्र, लागण झालेले रुग्ण आठवडाभरात बरे होत आहेत.
